Congregation of the Passion

In December 2014 the National Board for Safeguarding in the Catholic Church in Ireland NBSCCCI undertook a review of Safeguarding Practice in the religious Congregation of the Passion of Jesus Christ (The Passionists). The NBSCCCI made twelve recommendations and the following is the progress made to date and accepted by the National Board for Safeguarding. The Passionists of St. Patrick's Province remain committed to creating a safe, healthy and inclusive environment for all, particularly, the children, young people and vulnerable adults with whom we work. The participation of children and young people is valued and encouraged by all Passionists in their pastoral ministry and in activities that enhance their spiritual, physical, emotional and social development. The Passionists recognize the dignity and rights of all children and vulnerable adults and are committed to their support and safeguarding.

| 5. | The Provincial should ensure that all active files are structured account to NBSCCCI guidance. | All files have been restructured to reflect the guidance of the NSBCCCI. |

| 6. | The Provincial should ensure that the interim revision of the Passionist child safeguarding document makes full reference to Criteria $3.5 - 3.9$, in relation to anti-bullying, whistle blowing, dealing with unacceptable behaviour, anti-discriminatory practice and intimate care for children with disabilities. | The Passionist Policy contains sections on anti- bullying 4.4, whistleblowing 8.6, discipline and unacceptable behaviour 4.5, anti-descriminatory behaviour 4.2, and the care of children with disabilities 4.3. |

| 10. | The Provincial should, in conjunction with NBSCCCI, review and extend the scope of the Covenants of Care to explicitly state restrictions on contact with children and young people. | The Covenants of Care have been revised to include explicit restrictions in relation to contact with children and young people and venues where they may be present. |
| 11. | The Provincial should immediately establish that one of the roles of the Advisory Panel is to formally review all existing Covenants of Care on a regular basis, and should also ensure that the training and support needs of the personnel who manage and monitor the covenants are kept under review. | The Review of the Advisory Panel is taking account of the changes to the Covenants of Care and the requirement that they be monitored. Independent supervision and support has been secured for the Superior of the men out of ministry. |
| 12. | The Provincial should clarify the terms of reference of the Safeguarding Committee in conjunction with the NBSCCCI, setting out its role within the overall safeguarding structure, and its accountability to him and to the Provincial Council for monitoring all preventative aspects of safeguarding within the Passionist congregation as a whole. He should require an annual report from the committee on the implementation of the safeguarding standards within the Passionist congregation. | The role of the Safeguarding Committee has been revised since last February in accordance with the recommendation. |
